CARD CHARGES

Swipe card yearly charge is **\$50**, cost per game is \$5.00 (minimum credit purchase 4 games)

CODE OF RESPONSIBILITY

Please read the following and sign in the identified sections.

1. Hours of Use – The court is available from 6 am with the last booking for a game at 9.15 pm (10 pm closing) seven days per week.
2. Games begin promptly on the 45 minute roll over. If you are late starting you will still finish at the beginning of the next time slot regardless of whether the lights have turned off. No other players are to be held up.
3. Bookings will only be made up to one week in advance and no more than two games can be booked at one time (this allows for a back to back booking)
4. The card is not to be loaned to other families. This is important as the facility is monitored and any damage caused during the time your card is active will be your responsibility
5. Outside shoes must not be worn on the court, and only non-marking shoes used when playing (no bare feet)
6. Gum, drink and food are not allowed.
7. Complex is totally alcohol, smoke and drug free
8. Children under 14 years of age are under the direct control of their parent or caregiver at all times
9. All rubbish etc to be removed at the conclusion of your game from the centre
10. A lost card will incur a cost of \$10.00 for replacement and accumulated credits may be forfeited.
